ACCOUNTING AND PETITION FOR DISCHARGE**


Petitioner, Michael I. Goldberg, by and through his undersigned counsel states:

1. Petitioner is the Personal Representative of the above Estate.
2. The status of the administration of this Estate is Letters of Curatorship were issued to Petitioner on September 22, 2010, Notice to Creditors was published on September 29, 2010 and the Inventory of the assets of the probate Estate will be filed on or before December 31, 2011 pursuant to an extension granted by this Court.
3. Petitioner cannot file a Final Accounting and Petition for Discharge within the time specified in Fla. Prob. R. 5.400 because the Estate has over 133 claims filed against the Estate and the Curator is in the process of transferring the Investor Claims, Business Claims and the Capital Analysts, Inc.
